## BURSARY TERMS & CONDITIONS

1. Volunteers are not eligible to apply
2. Return economy flights will be provided from a NSW airport to Sydney Airport Domestic Terminal and return.
3. Accommodation will be provided for Sunday 30 July 2023 and Monday 31 July 2023 **OR** Monday 31 July and Tuesday 1 August 2023 (2 x nights)
4. Meal allowances will be provided as follows:
  - a. Breakfast x 2 mornings and only through the hotel restaurant. Maximum allowance is \$15 per meal.
  - b. Dinner x 2 evenings and only through the hotel restaurant. Maximum allowance is \$35 per meal.
  - c. The above can be charged back to the individual's room – any amount over the designated maximum is to be paid by the individual.
  - d. Receipts and a completed reimbursement form for meal allowances will be required, pending bursary approval.
  - e. Please note – Organisers are unable to:
    - Provide reimbursement for meals purchased outside of the above arrangements
    - Pay for any excess amounts above the nightly amount
    - Pay for daily amount combined
5. Taxi allowances will be provided to/from Sydney Airport to either your accommodation or the CPWF venue. Please note, organisers are unable to include taxi vouchers or reimbursement to/from the individual's home to the airport.
6. There are 10 full bursaries available for the 2023 CPWF. Additional bursaries *may* be available pending the cost of initial applications.
7. Bursaries are **ONLY** available to staff of NSW Health who are employed in designated lived experience (consumer) roles in fulltime, part-time, or casual employment capacity.
8. Priority will be given to those peer workers who are living and working in regional/remote NSW and who do not receive financial support from their local health district.
9. Any expressions of interest/applications submitted after the closing date may not be considered.
